**Command and Control System – Consolidated (CCS-C)  
Production & Sustainment Contract (CPASC)**

Baton Rouge, La. - January 31, 2013 – Keta Group, LLC (“Keta”) announced today that its subsidiary, CP Resources, is part of a team led by KRATOS Technology and Training Solutions (“KTTS”) which has been awarded the Command and Control System – Consolidated (“CCS-C”) Production & Sustainment Contract (“CPASC”). This contract has a term of one base year plus four one year options for a total of five years and is a follow-on to the CCS-C contract, F04701-01-C-0012, under which CP Resources was also a subcontractor to KTTS.

The Command & Control System – Consolidated (CCS-C) is a ground control system used by the 50th Space Wing at Schriever AFB to fly the military communication satellites under the operational control of the 3rd and 4th Satellite Operations Squadrons. In 2003, CP Resources installed and maintained the CCS-C simulator system at the 533rd Training Squadron, Vandenberg AFB. The CCS-C simulator replaced the Crew Training Emulator (CTE) maintained by CP Resources since 1992. The CP Resources Site Manager (SM) provides Facility and System Activation support. The project continues with Network/System Administration for the twelve CCS-C simulators, and hardware maintenance at the Line-Replaceable Unit (LRU) level. This project also includes support to the Backup Satellite Operations Center (BSOC-V) at Vandenberg AFB. CP Resources serves as the first point of contact for Vandenberg AFB CCS-C site support issues.
